Instructions for filling the Application.

I. Identity :-

Please mention the Identity Card No. issued by the Department of Registration of Persons. Please note that a photo-copy of the identity card should be annexed to the application.

II. Attestation of Residence:-

Please note that the certificate of attestation of residence issued by the Grama Niladhari for the period of recent six months and attested by the Divisional Secretary should be annexed to the application.

VII. At least 3 issues of the newspaper should be submitted in order to decide whether the newspaper is in a suitable manner to be registered. If only the newspaper is found to be not obscene or indecent or do not infringe the code of ethics and act No 5 0f 1973 it will be registered with the Sri Lanka Press Council.

Sri Lanka Press Council Law, No 5 of 1973 of the National State Assembly.

Section 25

"Regulations may be made under this Law for the registration of the proprietors and editors of newspapers in respect of their newspapers, and the levy of fees in respect of such registration."

Section 26

"For the purposes of this Law, the printer and publisher of every newspaper shall, on each day on which such newspaper is published or in the day next following which is not a holiday, cause to be delivered at the office of the Commissioner a copy of such newspaper and of every subsequent and other varied edition or impression of such newspaper so printed or published with the name and place of residence of the printer or publisher thereof signed and written thereon, after such name and address are printed by his hand and in his accustomed manner of signing or by some person appointed and authorized by him for that purpose, and of whose appointment and authority due notice in writing signed by such printer or publisher is given to the Commissioner."
